Subject: Activities for Election / Nomination (Nomination of students from National Service Scheme, National Cadet Corps, Sports and Cultural activities on Students' Council) and its modus-operandi, illustrations, materials, personnel required, formats etc. for constitution of University Students' Council, University Department Students' Council, College Students' Council u/s 99 of Maharashtra Public Universities Act, 2016.

Whereas, the Maharashtra Public Universities Act, 2016 (hereinafter referred as the Act) came into force w.e.f. 1st March, 2017, in which u/s 99, the constitution of Students Council is prescribed by way of Election and Nominations,

And

Whereas, as per provision u/s 99(11) of the Act, the Government of Maharashtra, Higher and Technical Education Department has issued Order no. PARINI. 2018/C. R. No. 81/VISHI-2, 26 October 2018 for conduct of election of Students Council and the Uniform Statute No.7 /2018 No. PARINI- 2018/C. R. No. 103/VISHI-2, Dt. 26 Oct. 2018 for Nomination u/s 99(2)(f), (3)(f) and (4)(b)(v) of the Act thereon,

And

Whereas as per Government Order and Uniform Statute, the activities and illustrations for conducting the election and make nominations, modus-operandi, formats like notice of withdrawal, ballot papers, procedure for election at polling centres, voters identity card for University Students Council election, reports, order of rotation policy for reservation seats, policy of drawing lots, publications, submission etc. are to be notified for information and necessary action of all concerned. It is hereby notified that the following shall be the procedure for constitution of the University Students Council, University Department Students Council and College Students Council by election/nomination in each academic year.

1. In this Notification, unless the context otherwise requires

- (a) "Ballot Box" means the suitably designed box to collect voting slips/ballots paper of voting in accordance with the number of voters.
- (b) "Campus" means an area under the college or institution or University.
- (c) "Caste Certificate" means a documentary proof which certifies the individual's cast issued by competent authority.
- (d) "Lots" means a procedure for fixing the roster point of reservation of representative in a College/Institution/University Department/University Students Council for cycle of rotation.

- (e) "Polling Centre" means a place of College/ Institution/University Department/ where voters cast their votes.
- (f) "Polling Officers" means the teacher/s who may be one or more as the case may be, to be appointed by Principal/Director / Director of Students Development who monitor the voting procedure and guide/assist the voters in the election process.
- (g) "Rotation" means allotment of seats for candidates of reserved category who is the member of the concerned council till the last day of the academic year.
- (h) "Withdrawal Form" means a prescribed form for the purpose of withdrawal of candidature by candidate for not contesting the election, appended as "**Appendix-21**".

Words and expressions appearing not here in after defined shall have the same meaning as in the Maharashtra Public Universities Act, 2016 and allied statutes, ordinances and regulations.

2. The process/ modus-operandi for nominations /election shall be followed vide part-I and part-II as under.

Part-I

NOMINATION OF STUDENTS ON STUDENTS' COUNCIL

1. In support of relevant clauses in government order and uniform statute as mentioned above, the authority shall adopt the following process/modus-operandi for giving score to the outstanding performance of students in respective fields.

I. National Service Scheme (NSS)

- (i) District/University/Regional Level Participation: 2 marks per camp
- (ii) State Level Participation in Adventure Camp, Utkarsh, Awahan Disaster Management Camp, Prerana Leadership Camp: 2 marks per camp
- (iii) National Level Participation (RD parade, NIC Camp): 4 marks per camp
- (iv) International Level Participation: 5 marks
- (v) Blood Donation: 2 marks

II. National Cadet Corps (NCC)

- (i) Passing "B" Certificate: 2 marks.
- (ii) Passing "C" Certificate: 4 marks.
- (iii) National/Regional Level Participation or Attending NCC Camp/ CATC/National Integration Camp (NIC)/ Basic Leadership Camp (BLC)/All India Basic leadership (ALC) /Adventures Camp (Trekking/ Paragliding/ Scuba Diving) Competition /Parades etc. : 2 marks per event

- (iv) Securing the Position / Medal in National Integration Camp (NIC)/ Basic Leadership Camp (BLC) /Adventures Camp (Trekking/ Paragliding/ Scuba Diving) (1 mark per medal)
- (v) Participation in Thal Sainik Camp (TSC)/ All India G.V. Mavlankar Shooting championship Competition (4 marks per event)
- (vi) Participation in International Youth Exchange Program (YEP)/ Republic Day Camp (RDC): 5 marks per event.
- (vii) Participation in any other NCC activity (Swachh Bharat Abhiyan/Pulse Polio Immunization/ Tree Plantation/Awareness Rally/Blood donation): 1 mark per activity.

III. Sports

- (i) Participation in Inter-collegiate Sports Tournament: 2 marks per event
- (ii) Participation/Representation in Zonal Inter-University Sports Tournament: 5 marks per event
- (iii) Obtaining a Position at Zonal Sports Tournament conducted by AIU: (5 marks for First Position, 3 marks for Second Position, 2 marks For Third Position Per medal)
- (iv) Participation/Representation in All India Inter-University Sports Tournament conducted by AIU: 5 marks per event
- (v) Obtaining a Position at All India Inter-University Sports Tournament conducted by AIU: (5 marks for First Position, 3 marks for Second Position, 2 marks for Third Position per medal)
- (vi) Participation in Combine Universities Sports Tournament: 5 marks per event
- (vii) Obtaining position in the Combine Universities Sports Tournament : (5 marks for First Position, 3 marks for Second Position, 2 marks for Third Position per medal)
- (viii) Participation in State level Sports Tournament organised by Governmental agency: 5 marks per event
- (ix) Obtaining position in the State level Sports Tournament organised by Governmental agency: (5 marks for First Position, 3 marks for Second Position, 2 marks for Third Position, per medal)
- (x) Participation in the National level Sports Tournament organised by Governmental agency: 5 marks
- (xi) Obtaining position in the National level Sports Tournament organised by Governmental agency: (5 marks for First Position, 3 marks for Second Position, 2 marks for Third Position, per medal)
- (xii) Participation in the International Sports Tournament: 5 marks
- (xiii) Obtaining position in the International level Sports Tournament: (5 marks for First Position, 3 marks for Second Position, 2 marks for Third Position, per medal)

IV. Cultural activities

- (i) Participation in Inter-collegiate Youth Festival conducted by University: 2 marks per event
- (ii) Participation/Representation in Zonal Inter-University Youth Festival conducted by AIU : 5 marks per event
- (iii) Obtaining a Position at Zonal Youth Festival conducted by AIU : (5 marks for First Position, 3 marks for Second Position, 2 marks for Third Position, per medal)
- (iv) Participation / Representation in All India Inter-University Youth Festival: 5 marks per event

- (v) Obtaining a Position at All India Inter-University Youth Festival conducted by AIU. : (5 marks for First Position, 3 marks for Second Position, 2 marks for Third Position per medal)
 - (vi) Participation/ Representation in South Asian Universities Festival (SAUFEST): 5 marks
 - (vii) Participation in the State level Cultural activity organised by Governmental agency: 2 marks per event
 - (viii) Obtaining position in the State level Cultural activity organised by Governmental agency: (5 marks for First Position, 3 marks for Second Position, 2 marks for Third Position, per medal)
 - (ix) Participation in the National level Cultural activity organised by Governmental agency: 5 marks per event
 - (x) Obtaining position in the National level Cultural activity organised by Governmental agency: (5 marks for First Position, 3 Marks for Second Position, 2 marks for Third Position, per medal)
 - (xi) Participation in the International Cultural activity: 5 marks
 - (xii) Obtaining position in the International level Cultural activity: (5 marks for First Position, 3 marks for Second Position, 2 marks for Third Position, per medal)
2. The procedure of inviting applications with duly attested true copies of certificates for nomination of the students from National Service Scheme, National Cadet Corps, Sports and Cultural Activities to University Department Students Council/ College Students Council, shall commence with the election schedule. The authority shall issue notice/instruction to all the students to apply for nomination on the basis of National Service Scheme, National Cadet Corps, Sports and Cultural activities. After collecting the application forms, the score shall be calculated on the basis of performance.
3. After completing the said process, the authority shall submit the names and score with attached certificates or documents of the nominated students online as per the form in **Appendix-18**.
4. The declaration of nomination of the students from National Service Scheme, National Cadet Corps, Sports and Cultural Activities to University Department Students Council, College Students Council and University Students Council shall be done after the election of President, Secretary, Ladies Representative and Representative of Cast as the case may be.

Part-II

ELECTION TO STUDENTS' COUNCIL

The reservation policy of the Government of Maharashtra shall be followed for section 99(2)(d), (3)(d), (4)(b)(iv) of the Act from time to time.

I. Procedure for drawing lots for representation of reserved categories:-

- i) The Director of Students Development, in consultation with Vice-Chancellor, shall fix the date and time for declaration of allotment of category wise reservation for the election of the candidate from the reserved categories under section 99 (2) (d), (3)(d) and (4)(b)(iv) of Maharashtra Public University Act 2016. On the date fixed for this purpose, the Director of Students Development shall place a container which shall contain chits bearing names of the categories and thereafter lots will be drawn. The cycle of Roster for Rotation, shall be initiated from first election for keeping reservation for the specific category.

Election Schedule

(A) For University Department Students' Council and College Students' Council

The College/Institute/University shall prepare the electoral roll for the election of College Students' Council and University Department Students' Council as per the procedure laid down in subsection 8 of Order no. PARINI. 2018/C. R. No. 81/VISHI-2, 26 October 2018. The dates of the procedure shall be notified by Notification in Part Two Gazette, of the University.

Appointment of Election Officer

The appointment of election officer shall be done as per Order no. PARINI. 2018/C. R. No. 81/VISHI-2, 26 October 2018 for conduct of election of Students Council and the Uniform Statute No.7 /2018 No. PARINI- 2018/C. R. No. 103/VISHI-2, Dt. 26 Oct. 2018. The authority shall issue the nomination letter as per the *Appendix-1*.

Ballot Paper

The voting shall be done by ballot paper. The ballot paper shall bear the names of the contesting candidates in English serially arranged according to alphabetical order with reference to surnames first as per *Appendix-2.1, 2.2, 2.3, 2.4, 2.5* for University Department Students Council, *Appendix-3.1, 3.2, 3.3, 3.4, 3.5* for College Students Council and *Appendix-4.1, 4.2, 4.3, 4.4* for University Students Council. The paper used for ballot paper shall not be below 60 GSM thickness. The colour of the ballot paper for the University Students Council, University Department Students Council and College Students Council shall be as given below. The ballot shall have foil and counter foil. The counter foil shall contain the name of student and his signature. Every counter foil of ballot paper shall bear its serial number.

Ballot Box

In the case of University Department Studentsø Council and College Studentsø Council election the size of the ballot box will depend on the total number of voters in voter list. Each College/Institute may take decision about the size and shape of the ballot boxes. The ballot boxes may be of metallic make with lock and key facility.

In the case of University Studentsø Council election the ballot box shall also of metallic make with lock and key facility. The maximum number of the paper ballot should be 16, hence size of ballot box shall be about 9 inch tall and 6 inch wide approximately.

Polling Centres

For the election of University Department Studentsø Council and College Studentsø Council, number of voters shall not more than 120 for each polling centre/polling booth.

Provided that the election officer shall fix the polling centres more than one for a Class / Department taking into consideration the strength of that particular Class / Department.

Procedure for Election at Polling Centres

In all cases when an election is held wherein votes are to be recorded at polling centres, the procedure for the recording of votes by ballot shall be as under :

- (1) Respective college shall be the polling centre for College Studentsø Council and University Studentsø Council. And respective University Department shall be the polling centre for University Department Studentsø Council. The election officer shall appoint as many Polling Officers as are necessary at the polling centres from the teachers.
- (2) It shall be responsibility of the Principal of affiliated or conducted colleges and Heads of the recognized institutions and the University departments to provide all necessary infrastructure, support facilities and man power for the smooth and timely conduct of elections.
- (3) The polling officer shall ensure that the law and order is maintained at the polling centre. No person other than a voter shall be permitted to enter in the college/department premises.
- (4) No voter shall be allowed to enter the polling compartment for recording his vote before the commencement or after the expiry of the time fixed for the voting.
- (5) Immediately before the polling commences, the polling officer shall show to the candidate or his authorized agents present at the polling centre that the ballot box is empty and shall then lock and seal it for the use. A certificate is signed by them as per *Appendix-22* supplied for this purpose.
- (6) Polling officer-2 shall issue a ballot paper immediately after confirming identification of voter by the Polling officer-1. Before the ballot paper is issued to a voter his/her Sr. No. of electoral roll shall be put on the ballot paper counter foil, and the same shall be signed by the voter and tick mark (ç) shall be done by the issuing officer in his copy of the electoral roll against the number of the voter to whom the voting paper is issued. Polling officer-1 shall take his/her signature on the electoral roll.

- (7) The voter on receiving the ballot paper shall forthwith proceed to one of the polling compartments, where he/she shall mark tick (ç) to show his/her vote on ballot paper and put her/his ballot paper into the appropriate ballot box.
- (8) If the polling officer is satisfied that owing to blindness or other physical infirmity, a voter is unable to put a mark/preferences on the ballot paper without assistance, he shall permit the voter to take with him a companion of not less than eighteen years of age to the polling compartment for recording the vote on the ballot paper on his behalf and in accordance with his/her wishes, and, if necessary, for folding the ballot paper so as to conceal the vote and inserting it into the ballot box.
- Provided that, no person shall be permitted to act as the companion of more than one voter at any polling centre on the same day.
- Provided further that, before any person is permitted to act as the companion of a voter on any day, he shall be required to declare that he will keep secret the vote recorded by him on behalf of the voter and that he has not already acted as the companion of any other voter at any polling centre on that day. The polling officer shall keep a record of such declaration and submit the same to the Authority for election of Studentsø Councils.
- (9) Every voter shall vote without undue delay, and shall leave the polling room, as soon as, he has put his ballot paper into the ballot box.
- (10) After the voting hours are over, the ballot box shall be sealed and handed over to the election officer for counting process of the College Studentsø Council and University Department Studentsø Council as the case may be. In the case of University Studentsø Council the ballot boxes shall immediately be sent to the University with related documents.
- (11) If a voter spoils his ballot paper inadvertently, he may be given another and the spoiled paper and its counterfoil shall be cancelled by the polling officer. All spoiled papers and counterfoils shall be sent to the relevant authority for election by the polling officer.
- (12) The voters shall not be allowed to carry mobile phones, tablets or any other electronic communication gadgets in the polling compartment.
- (13) After completing the voting process polling officer shall mention the accounts of ballot paper and signature of candidate/polling agents in the format as per *Appendix-24*

Polling Officer

The appointment of polling officer shall be done for the College Studentsø Council and University Department Studentsø Council by the election officer. For the election of University Studentsø Council the appointment of polling officer shall be done as per Order no. PARINI. 2018/C. R. No. 81/VISHI-2, 26 October 2018 and shall be confirmed by issuing a letter as per *Appendix-5*.

Polling Agent

The candidate or his agent, who shall be a voter of a particular constituency, duly authorized by him in writing, on his behalf shall be entitled to be present at such polling centre as per *Appendix-8*.

Voter identity card for University Students Council election

Voter identity card for University Students Council election shall be issued by the authority as prescribed vide *Appendix-6*.

Scrutiny/ Counting of votes

All voting papers shall be scrutinized by the Election Officer or by such other person or persons as may be authorized by the Election Officer. The Election Officer may delegate his power in relation to scrutiny and counting of voting papers to any other person or persons under his control. After every round of counting the votes shall be mentioned in the *Appendix- 20*. In case of University Studentsø Council the votes of each round shall be mentioned in the *Appendix-19*. The election officer shall nominate the Scrutiny/ Counting officer as per *Appendix-7*.

The candidate or his agent, who shall be a voter of a particular constituency, duly authorized by him in writing on his behalf shall be entitled to be present at such scrutiny/counting as per *Appendix-8*.

The certificate as per *Annexure-23* be signed by the agent/ candidate that ballot box was found sealed and in proper order before breaking the seal. After opening the ballot boxes the accounts of ballot papers shall be checked in the ballot box as mentioned in *Appendix-24* and the scrutiny report of ballot paper shall be recorded in *Appendix-25*

Election Report

During the election process each and every result of election to Studentsø Council, the election officer shall send the various reports as provided by the University within 12 hours after declaring the result. The format of report shall be as per *Appendix-9 to Appendix-17*

Expenditure for Conduct of Election:

The College/Institute/University shall bear the expenditure for conduct of elections to the College Studentsø Council/University Department Studentsø Council and University Studentsø Council, as the case may be.
